Interested vendors/suppliers/distributors with requisite experiences, as mentioned in the "Expression of Interest" notification on the college website, are requested to submit their EOI with relevant supporting documents. All necessary details, including eligibility criteria, terms and conditions, and application form (Annexure-I) are available at the college campus or website.

# **EXPRESSION OF INTEREST** FOR EMPANELMENT OF REPUTED BOOK PUBLISHERS/SUPPLIERS/VENDORS FOR FINANCIAL YEAR 2025-2026, 2026-2027 & 2027-28.

The Principal Govt. Degree College Kotranka/Peeri invites "Expression of Interest" for empanelment of reputed book publishers/suppliers/vendors for supply of books for financial years 2025-26, 2026-27 & 2027-28.

The eligibility criteria, terms, and conditions to be followed by interested parties are as under:

#### **ELIGIBILITY CRITERIA**

Proof of the following-mentioned supporting documents must be enclosed in support of the eligibility criteria and the absence of any will lead to rejection:

- 1. Book publisher /Supplier/vendors must be a regular service provider to at least one premium government institute of J&K UT for Higher Education.
- 2. Registration with the Federation of Publishers' and Booksellers' Association in India (FPBAI).
- 3. Permanent Account Number (PAN) issued by the Income Tax Department.
- 4. Evidence of Income Tax clearance certificate of at least the last three consecutive years.
- 5. Book sellers should be sole proprietorship certificate holders.

Note: The applicant should read all terms and conditions properly before submitting the application for empanelment.

# GENERAL TERMS AND CONDITIONS

- 1. Applications received after the due date/time will not be accepted.
- 2. All pages of the Empanelment documents must be signed and stamped by the firm.
- 3. Application must be submitted with DD of ₹5000 as security deposit in favour of the Principal Govt. Degree College Kotranka/Peeri. & the Security deposit will be returned after the expiry of the empanelment period. However, in case of unsatisfactory performance during the empanelment period, security deposit will be
- 4. The college reserves the right to accept/reject any offer without assigning reasons.

# SPECIAL TERMS AND CONDITIONS

1. Discount: The supplier/vendor is expected to extend a Maximum discount on all types of books. In case the rate of discount varies, then the highest discount offered will apply to all the eligible book suppliers/vendors. However, if anyone disagrees, the firm can be withdrawn from the empanelment.

2. Conversion Rates: The Supplier should submit the necessary supporting documents/Good Office Committee (GOC)conversion rates for foreign books.

3. Editions of Books: Only the latest editions to be supplied.

4. Order Acknowledge: Orders must be acknowledged within 7 days from the date of the Order.

5. Paperback/Hardback: If a paperback edition is not available, the supplier must consult before supplying a hardback edition.

6. **Book Supply Time:** The Maximum time limit for supplying Indian books is 15 days, and for foreign books is 30 days.

7. **Blacklisting:** Non-supply within the stipulated time for 3 consecutive times leads to blacklisting unless a valid reason is provided.

8. Order Cancel: Orders would be treated as cancelled if the books are not supplied or no report as to the availability or otherwise is received within the stipulated time.

9. Price Proof: The supplier shall provide the publisher's price proof/publisher's catalogue along with the supply of books in support of the price not printed on the books.

**10. Transportation:** Books must be supplied to the library with no extra transportation charges, and no extra/other charges are admissible.

11. Payment: The final Payment shall be made in Indian Rupees within the stipulated time from the date of receipt of the invoice. The final invoice/'s in triplicate shall be submitted along with a photocopy of your agency PAN card/GST details/Bank Account details for the payment.

12. Replacement Copy: Torn/Damaged books must be replaced with fresh copies.

**13. Billing Address**: Bill(s) are to be addressed to "Principal, Govt. Degree College Kotranka.

**14. Arbitration:** In case of any dispute, the same shall be resolved initially by mutual discussion between the parties within 60 days, failing which the appropriate court at Rajouri will have the jurisdiction to adjudicate upon the matter.

**15. Modifications:** The College reserves the right to modify/change/delete/add any terms and conditions before issue of the agreement.
